## Drill/Exercise Planning and Documentation Assistance

We provide expertise and assistance in developing, planning, executing, and documenting a wide variety of multiple casualty drills and exercises. These drills and exercises are conducted in accordance with Homeland Security Exercise and Evaluation Program (HSEEP) guidelines. Planning assistance is tailored to the specific needs of your organization.

- Exercise Vests (Available in white/observer, red/evaluator or plain red, yellow, green & blue vests with clear identification pouches.)

- Moulage make-up kits available for loan
- Prefabricated (strap-on) wound kits available for loan
- Moulage training
- Moulage artists (Artists come for a regional team of volunteers and may not always be available.)

## Scenario Patient/Victim Card Packages

A patient scenario card package consists of a spreadsheet listing all of the patient and their respective injury/illness and triage information and printable patient card. The cards are designed to be double side printed on card stock. The initial triage criteria and presenting symptoms are on the front of the cards and the secondary triage criteria are on the back of the cards. A blank, fillable PDF template for the patient symptom cards is also available for use.

- Air show event (56 patients: R-21; Y-9; G-21; B-5)
- Tour bus accident (54 patients: R-20; Y-9; G-20; B-5)
- Passenger aircraft crash into water incident
- Bleacher collapse event (54 patients: R-20; Y-9; G-20; B-5)
- Active shooter incident
- Senior Center small bus accident (22 patients total: R-7; Y-6; G-8; B-1)
